## OVERVIEW OF MAYOR NEO GEORGE MASEGELA

Greetings to the people of Gasegonyana,

As we approach the conclusion of the 2024/2025 financial year, I would like to extend my sincere gratitude to our Councillors and municipal administration for their continued commitment to improving the lives of our residents. Your dedication in the face of persistent challenges is both recognised and appreciated.

This newsletter serves as an important communication tool to keep you informed of the work undertaken by the municipality. It reflects our efforts to ensure transparency, accountability and community engagement.

### Marking Key Moments of National Significance

April, as Freedom Month, gave us the opportunity to reflect on South Africa's journey to democracy. It reminded us of the sacrifices made for the freedoms we now enjoy and our collective duty to protect those freedoms.

On 1 May, we commemorated Workers' Day, honouring the role of labour movements and trade unions in securing democracy and advocating for workers' rights. It was also a moment to recommit ourselves to promoting fair labour practices and inclusive economic growth.

As we are in Youth Month, we are reminded of the bravery of the 1976 generation and recognise the importance of investing in the youth of today. We are implementing skills development and empowerment programmes aimed at enabling our young people to take charge of their futures.

### Advancing Service Delivery and Planning for the Future

On 30 May 2025, in a landmark step that sets the tone for local governance in the coming year, I tabled the 2025–2026 Integrated Development Plan (IDP) for approval and adoption by Council. This strategic blueprint for municipal development was shaped through extensive public consultations and stakeholder engagements. It stands as a collective vision between the municipality, our communities, and key partners to drive sustainable growth and inclusive governance. The IDP will guide all municipal planning, budgeting, and implementation processes, ensuring that development is aligned with the real needs of our people. Its successful adoption is a testament to participatory democracy at work.

### Health and Community Engagement Highlights

On 22 May 2025, the Northern Cape MEC for Health, Hon. Maruping Lekwene, launched the 1.1 Million "Close the Gap" HIV Campaign under the theme "Stay and Start on HIV Treatment" at Wrenchville Community Hall. This campaign is a collective call to action to ensure that 95% of people diagnosed with HIV are on treatment by December 2025. I had the honour of delivering the welcome address at the launch, where I urged all community members to get involved—by spreading awareness, encouraging testing, and supporting those living with HIV. The John Taolo Gaetsewe District has a crucial role to play, with a target of 6,159 individuals to be placed on ARV treatment before the end of November 2025.

### Dialogue and Service Response.

Earlier in the month, on 2 May 2025, I chaired a meeting with the Get Kasi Back Community Group—a collective of concerned residents from Mothibistad—at the Ga-Segonyana Local

Municipality Council Chambers. The group raised pressing issues, including water supply, waste management, ward delimitation, electricity, and infrastructure development. I am thankful that the community reached out to my office.

Together, we committed to strengthening our collaboration to improve the state of Mothibistad. A consultative meeting on ward delimitation/demarcation has been completed. Director Kgosieng presented a detailed update on boreholes supplying water to Mothibistad and surrounding areas.

A joint action plan between the municipality and residents will be developed to implement sustainable waste management and environmental upkeep measures. This includes fencing of the local park and installing cement bins in strategic areas. To support this work, I have established a Rapid Response Team that will intensify the Keep Gasegonyana Clean Campaign, with a specific programme focus for Mothibistad to commence after the conclusion of the Draft IDP & Budget consultative meetings.

## Road Safety Advocacy

On 15 April 2025, the Northern Cape MEC for Transport, Safety and Liaison, Hon. Limakatso Koloi, launched the 2025 Easter Road Safety Campaign in our district. The event was well-attended by stakeholders including traditional leaders Kgosi-kgolo Jantjie and Kgosi Tsinyane, the Provincial House of Traditional Leaders, District Speaker Cllr Ephraim Aiseng, Gasegonyana Councillors, traffic chiefs from across the province, and representatives from SANTACO. MEC Koloi's campaign served as a timely reminder of the shared responsibility we all bear in promoting safer roads and protecting lives during high-traffic periods and beyond.

In Conclusion, as the sphere of government closest to the people, our mandate remains clear: to deliver basic services and deepen democratic participation. We are proud of the strides made, and we remain fully committed to addressing community needs through inclusive planning, bold action, and ongoing dialogue.

In May 2025, the Municipality successfully hosted a series of Integrated Development Plan (IDP) and Budget outreach meetings. *"The Municipal Manager must prepare, or take all reasonable steps to ensure the preparation of, the budget-related policies of the municipality, or any necessary amendments, for tabling in Council within the deadlines specified by the Mayor."*

This is critical to ensuring that our financial planning is not only legally compliant but also strategically aligned with community priorities and expectations.

In addition, the Municipality held a **Strategic Policy Review Session in May 2025**, aimed at assessing and developing policies that are not only robust and future-proof but are designed to serve the broader public good rather than individual interests. This is a cornerstone of good governance.

While these strategic efforts lay the foundation, the success of our plans depends on the commitment and dedication of our municipal staff. I call on all employees to continue

## COUNCILLORS FORUM MEETING



Councillors Forum Meeting Focuses on Water Crisis, Sphaza Shop Verification, and Service Delivery Reporting

Kuruman, 09 April 2025 — The Ga-Segonyana Local Municipality Councillors Forum Meeting was held at the Council Chambers, chaired by Speaker Keamoetse Madikiza. The meeting brought together Municipal Councillors, Ward Secretaries, Senior Management, and officials from the Political Office to engage on key community matters affecting service delivery across all wards.

### Key Agenda Items Discussed:

- **Water Crisis Across Wards**

A major point of discussion was the ongoing water supply challenges affecting multiple wards. Councillors presented specific concerns raised by residents, with a focus on high-impact areas. The forum agreed on developing a coordinated plan of action that will include consultations with relevant departments and stakeholders to ensure short- and long-term solutions to the water crisis.

One of the primary contributors to the water crisis is the aging infrastructure that struggles to meet the demands of the growing population. The existing water infrastructure, designed to serve a smaller community is now overwhelmed, leading to frequent breakdowns, water losses, and inadequate supply. This strain

on the system not only affects the quality of service but also hampers efforts to ensure equitable access to this essential resource.

Compounding the issue of outdated infrastructure is the rampant vandalism and theft of municipal infrastructure at water boreholes. These acts of destruction not only disrupt water supply services but also result in significant financial losses for the municipality. The theft of critical components such as pumps, pipes, and electrical equipment further exacerbates the water crisis, leaving communities without access to this vital resource.

- **Community Meeting Reports**

Councillors shared feedback and reports from recent community engagement meetings, highlighting residents' concerns ranging from basic service delivery issues to infrastructure needs. The importance of structured follow-up and feedback mechanisms to communities was emphasized, to strengthen transparency and trust between local government and residents.

The Municipality has implemented a new process for obtaining proof of residence which has sparked mixed reactions from the community. Under the new system, residents are required to present proof of registration in a specific ward to obtain a proof of residence. While some community members have expressed frustration with the additional step, it's essential to understand

the importance of this process in ensuring the integrity of municipal services.

The primary objective of this new process is to prevent the misuse of proof of residence by individuals who claim to be residents of Ga-Segonyana but are not. By verifying ward registration, the municipality can ensure that services and benefits are directed to genuine residents, thereby protecting the interests of the community.

Registering with the Independent Electoral Commission (IEC) and being included in the voters' roll plays a crucial role in this process. Not only does it enable residents to participate in local government elections, but it also has a direct impact on the municipality's funding. A larger, accurately registered voter base can influence the allocation of grants and funding to support the population, ultimately benefiting the community.

## • Sphaza Shops Verification Update

Updates were shared regarding the verification process of Sphaza shops, including compliance and operational legality. The forum acknowledged the need to balance economic inclusion with regulatory compliance and proposed further collaboration with the LED and Law Enforcement Units to

manage informal trading effectively.

The Councillors Forum serves as a strategic platform where elected representatives collaborate, align on municipal priorities, and ensure that community grievances are addressed in a unified and transparent manner.

"This platform is not only for raising concerns but also for finding collective solutions. Councillors are the bridge between the Municipality and the community — it is vital that we maintain open communication and consistent feedback," said Speaker Keamogetse Madikiza.

The Speaker concluded the session by urging all councillors to maintain high levels of accountability and to strengthen public trust through regular engagement and clear reporting on service delivery progress.

## PAVING THE PATH TO PROGRESS IN MARUPING AND MOTHIBISTAD



Putting People First Through Infrastructure Development. In line with our commitment to Batho Pele ("People First") principles, the Municipality has made significant strides in improving local road infrastructure. The Maruping Tsago Road upgrading project (MIG) is transforming a 4.52km gravel stretch into a modern paved road. Residents can look forward to improved mobility and safety, with road signage and markings already in place. The 4.52km paved road is now complete.

Simultaneously, the Mothibistad Learamele and Methodist Sections are undergoing road upgrades to cover 2.9km of gravel road. While the project faced setbacks due to incorrect levels on Roads 5, 6, and 7, the Municipality has swiftly engaged engineers to rectify the issue, demonstrating our commitment to redress and ensuring long-term quality. These infrastructure upgrades not only improve daily living conditions but also facilitate economic growth, affirming our promise of value for money and efficient service delivery.

## WATER PROJECTS SECURE SUPPLY FOR COMMUNITIES

Access and Transparency in Basic Services. The Municipality continues to act on its mandate to provide sustainable and equitable access to water. Several high-impact projects under the Municipal Infrastructure Grant (MIG) and Water Services Infrastructure Grant (WSIG) are currently under way.

The Municipality is actively addressing water accessibility through large-scale projects such as the Dikgweng Donkerhook Bulk Water Supply, Mapoteng, Remmogo, and Seven Miles Block H. Funded through the Municipal Infrastructure Grant (MIG) and Water Services Infrastructure Grant (WSIG), these projects aim to provide clean, consistent water to all wards.

Notable achievements include:

- Over 15km of reticulation and installation of communal standpipes.
- New boreholes drilled, tested, and equipped across several villages.
- Storage reservoirs and elevated tanks constructed to improve supply efficiency.
- Refurbishment of vandalized boreholes as part of resilience building.

Through these efforts, Ga-Segonyana reaffirms its commitment to Equity, Consultation, and Service Accessibility, treating water not just as a utility, but a human right.

The Dikgweng Donkerhook Bulk Water Supply Project (Ward 12) is complete, pending Eskom's power connection approval.

In Remmogo (Maruping), the Municipality has finalized designs for a new water network, including additional boreholes, water balancing infrastructure, and street taps. Procurement processes are ongoing, and we remain committed to transparent communication and consultation as we expedite contractor appointments.

Despite challenges, including vandalism of boreholes at Mapoteng, the Municipality has worked closely with consultants to recast and redrill affected areas. These efforts reflect our dedication to accountability, access to quality services, and acting in the public interest.

## PUBLIC PARTICIPATION MEETINGS: WARD DELIMITATION



On the 29 April 2025 at Ga-Segonyana, Kuruman Town Hall the Municipal Demarcation Board (MDB) held a meeting with Ga-Segonyana Local Municipality stakeholders.

The purpose of the meeting is for MDB to explain the Ward Delimitation processes to the Traditional Leaders (Magosi), Councillors, Ward Committee members and CDWs for all the Fifteen (15) Wards of Ga-Segonyana. Present in this meeting includes Kgosi Kgolo Pelonomi Toto, Kgosi Kgolo Tumo Jantjie, Speaker Keamogetse Madikiza, Municipal Manager Mr Martin Tsatsimpe, Councillors, Ward Committee Members, CDWs and Officials of Ga-Segonyana.

The Demarcation Board after consulting the Electoral Commission must delimit a municipality into wards, each having approximately the same number of voters, taking into account the following criteria:

(a) The number of registered voters in each ward, may not vary by more than fifteen percent from the norm, where the norm is determined by dividing the total number of registered voters on the municipality's segment of the national common voters roll by the number of wards in the municipality.

(b) The need to avoid as far as possible the fragmentation of communities.

(c) The object of a ward committee as set out in section 72 (3) which is to enhance participatory

democracy in local government.

(d) The availability and location of a suitable place or places for voting and counting if appropriate, taking into consideration-

(i) communication and accessibility;

(ii) density of population;

(iii) topography and physical characteristics; and

(iv) the number of voters that are entitled to vote within the required time-frame.

(e) The safety and security of voters and election material.

(f) Identifiable ward boundaries.

The public has until 30th May 2025 for public inputs then after the closing date the public has Fourteen (14) days to register any dispute. The public is encouraged to register in IEC voters roll in order for the Ward Delimitation processes to resolve their Ward location. Attendees to the meeting were given forms for input and the public can get access to these forms as well.

On 25 May 2025 at Segonyana Primary School, Cllr Freddy Moagi chaired the Ward delimitation meeting for Ward 15, 03, 04 and 05.

The meeting was held with aim of informing the communities on the process of Ward delimitation by the Municipal Demarcation Board. The public were given break down of the official Voters roll numbers provided by IEC from the previous National Elections and the advice from Municipal Demarcation Board on how to balance the numbers in order for establishment of a new Ward.

Ga-Segonyana Local Municipality is working with Get Back Kasi concerned community group in preparation of Ward request proposal. The inputs of the community will be used as part of submissions to the MEC of COGHSTA in request for additional new Ward. Provided success of the proposal this will assist community members to be able to vote in voting stations in their residential areas.

The community expressed their dissatisfaction with their previous voting stations location which led to most of them deciding not to go vote. Provided that they are placed in the voting stations nearest to their residency they will participate in elections.
