1. Locality

- 1.1. Locality shall be deemed all bidders operating and stationed within the boundaries of John Taolo Gaetsewe District.
- 1.2. Expanded term for locality shall be deemed for bidders operating and stationed outside of John Taolo Gaetsewe District but within the Northern Cape Province.
- 1.3. Bidders shall provide proof of locality by submitting one or more of the following
- 1.4. Municipal Account in the bidder's name.
- 1.5. Proof of residence in the bidder's name.
- 1.6. Bank statement with the bidder's address.
- 1.7. Lease agreement indicating a local address, where the lessee is the bidder.
- 1.8. The bidder must submit proof of locality in order to claim points for locality.
